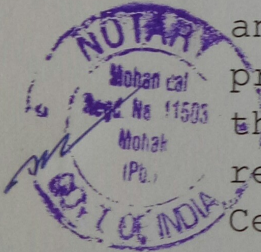
The affidavit along with the documents submitted by
the management of the school after considering the
recommendation of District Education Officer (SE) SAS
Nagar and the Director Education Department (SE)
Punjab. The No Objection Certificate is given as per
the following conditions :-

1. In case of any future complaint/inspection, if the
fact comes to light that the instruction issued by
you at the time of obtaining the No Objection
Certificate is not followed by you and thus the
conditions given in the affidavit are not complied
with, such a situation arises. This No Objection
Certificate can be withdrawn at any time.
2. That Punjabi language will be compulsory in your
school upto 10th standard and CBSE New Delhi will
make it mandatory to take Punjabi exams in such
schools and at the same time it is said that



failure to do so will result in immediate withdrawal of No Objection Certificate.

3. School Management, Education Department Punjab Govt. Notifications issued under the Act 2009 and RTEs issued by the State of Punjab. The rules of the Act 2009 will be strictly followed.
4. After taken the affiliation of CBSE, New Delhi, the management of the school would be committed to pay the teaching staff and non-teaching staff of the school with government employees' salary and other allowances by account pay check. At the time of school extension/upgradation, as per the instructions of the government, the reserve fund of teaching staff and non-teaching staff would be deposited with the concerned District Education Officer. Failure to do so will result in immediate withdrawal of the No Objection Certificate.
5. You and your management will also ensure it that whenever your District Education officer requests any kind of information, he or she will be provided with the required information as well as the necessary support. Failure to do so will result in immediate withdrawal of the No Objection Certificate.
6. The condition of issuance of Child Health, Public Health Sanitation and other No Objection Certificates will be periodically inspected by the Punjab Government officials.
7. The guidelines issued by the Punjab Government through letter No. 2/93/2009/3C3/1360154, dated 26-11-2018 will be strictly followed.



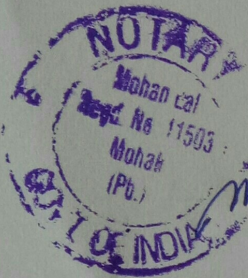
